Middle School / High School Principals' Report — Mr. Ahearne reviewed middle school/high school information. Custodians are working hard. Outer building has electricity and is all set. Limestone all around the building. The science tables are coming in late, all other furniture is delivered. We are down two teachers in middle school. Hiring a second paraprofessional for the high school, there are already several applications. CT classes- 2 business, 1 web design with Mrs. Carroll. Dual enrollment for Alpena Community College.

Superintendent's Report – Mrs. Shiffer gave an update. There are 2 open positions in middle school, special ed and math. Lindsay Major resigned in the kitchen. Transportation - Terri resigned. The Red Rover sub system will be used this year. There will be training for staff. FB compliance training, safe school is a much smoother training. We are working with Fairview for a joint letter to parents regarding the beginning of the school year. Advertising on radio stations 94.9 and 106.1 letting families know to come to our school. Expanding the sidewalk by the 3rd grade doors for a safer area for parents picking up their kids.
