Bolt of the Month Awards – Six sixth, seventh and eighth grade students were honored as Bolt of the Month. These students were honored for their academic and citizenship achievements. All six Bolt of the Month students, and their parents, were in attendance. President Irelan emphasized what an honor it is to be the recipient of this award. In addition, Mrs. Irelan thanked parents and guardians for their role(s) in helping these students become outstanding role models, not only through grades but through citizenship as well.

**Citizens' Comments** — Jim Gendernalik, a taxpayer from Luzerne, recognized and thanked the board members for their time and dedication to the district. Mr. Gendernalik stated that as a former employee he appreciated their support over the years. In addition, he thanked Mr. Jay Jackson, retired teacher, for his contributions to the district as a teacher and for his willingness to continue serving as a board member.

**Athletic Director's Report** – Mr. Demory thanked the board members for their service and stated that he realizes at times they have to make difficult decisions. Mr. Demory reported that the Athletic Policy meeting was canceled due to inclement weather. This policy committee meeting will be rescheduled. Winter sports seasons have begun. The Mio Chartier Wrestling Invitational event will be held this Saturday. Mr. Demory also announced that at the end of this school year, he will be resigning from the position of Athletic Director, with an effective date of June 30, 2019.

**Elementary Principals' Report** — Mr. Ciske reported on elementary happenings. The first grade drive-in movie event went very well. Winter NWEA testing is underway and should be completed over the next couple of weeks. There will be a book study beginning. To date, 20 staff members have signed up for this. Elementary Music will begin teaching square dancing to grades 4-5, with a performance held on February 27 at 1:00 p.m. The elementary spring concert will be held on April 30 at 6:00 p.m. Mr. Ciske reported that an interview was held for the vacant third grade teaching position. Upon completion of reference checks, an offer will be made to the applicant. There were 17 suspensions for the month of December, involving nine students. Currently there are 218 students in grades K-5.

**Buildings and Grounds Report** – Mr. Niles reported that he is working with Control Solutions of Alpena to optimize heating and lighting controls in an effort to be more cost effective. He also reported that Control Solutions will assist with information regarding lighting updates to LED. There are borrow/payback programs through energy savings and Consumer Energy Rebates available which could help pay for these updates. Currently seeking companies to bid on replacement of the roof over the high school wing. Looking to obtain both repair and replacement quotes. Continuing to look for less expensive parts for existing HVAC equipment. Mr. Niles stated that all janitorial supplies, excluding hand soap, will now be purchased locally from an in-town supplier.

Middle School / High School Principals' Report — Copies of the Curriculum Guide were distributed to board members for review. Mr. Niles is asking for these changes/updates to be approved at the February board meeting. Winners of the High School Art Event were announced. There were almost 50 drawings entered, with three students being chosen for their artwork. These students were recognized and presented with gift cards. A high school play will be held on January 7, with a middle school play on January 19. Exams are scheduled for January 16-18. Mr. Niles announced that he is preparing for state mandated testing in April 2019. High School students are now being recognized as Bolts of the Month. These students will not be attending board meetings, but will be recognized in the Oscoda County Herald. There were seven students suspended, with one student expelled.

Superintendents' Report - Mr. Ciske stated that one of the door barricades, funded with Security Grant funds, has been installed. These barricades will continue to be installed throughout the school. We currently have postings for a third grade teaching position, two paraprofessionals and bus drivers. We do have an applicant for the teaching position and will be conducting an interview as soon as possible. A current parapro sub, Lindsay Bills, is an applicant for the high school parapro position. We are very pleased with this applicant and would like to offer Ms. Bills the full time position. This will be an action item. There are currently no applicants for the elementary parapro or bus driver positions. Looking into increasing the pool of teaching applicants by offering to utilize student teachers. We will pursue this idea in hopes of increasing the teacher applicant pool in the future. Staff are interested in professional development training regarding how to talk to students in times of distress (suicide or self-harm), as well as relating to student trauma. Looking to pursue a Sinking Fund millage for items such as HS roof replacement, parking lot lighting and technology. Need to be conscious of community and district needs. Would like to have ballot language approved at the February board meeting. To date we had one full snow day on January 8, with an early dismissal on January 7. Mr. Ciske reported that Eidex is a data management company that has been contracted through COOR ISD. We are hopeful that it will provide a cost effective way to assemble data needed for school improvement reporting that may be able to replace Munetrix for transparency reporting. Mr. Ciske distributed a sample data report. Financial reports are now available for board review. Board members stated that they would like to receive these reports monthly.
